Renter: I hereby acknowledges that Renter may and/or intends to rent additional equipment from Cache Valley Trailer Rental LLC. By executing this agreement Renter agrees that unless stated specifically in writing, the terms of this agreement shall be binding on the Renter for all future rentals from Cache Valley Trailer Rental LLC. Renter's initialed acknowledgement: _____

Renter: I acknowledge and represent that I have proper licenses, permits, registrations and qualifications required to tow the trailer I am renting. I further acknowledge that I will be solely responsible for any citations I may receive for any violations regarding the improper licensing, permits, registrations and qualifications required while towing and renting the trailer and will hold Cache Valley Trailer Rental harmless from any such citation and/or fine. Renter's initialed acknowledgement: _____

Renter: I understand that I am to return the Trailer in the same condition as when I received it. I also understand if the Trailer is damaged, the damage/cleaning deposit will not be refunded if one was issued. If damages exceed the deposit, I am responsible for paying for all damages. I further understand the damage/cleaning deposit and credit card authorization form is to ensure that the Trailer is returned in the same condition. If the Trailer is returned without being sprayed clean, I will be charged a **\$50 CLEANING FEE** in addition to all other charges.

Renter's initialed acknowledgement: _____

I, as Renter, assume full responsibility for damage or injury resulting from my failure to provide a properly equipped towing vehicle. This means that the towing vehicle is of adequate size and power to handle the Trailer and has the necessary braking/tall light connections, adequate hitch, including correct ball size, and bumper, In addition, I am responsible to ensure that the Trailer has been adequately and properly hooked-up to the towing vehicle and hereby assume responsibility for the hook-up procedures.

Rental Pick-up and Return or Business Hours: Mon-Sat 8:00 a.m. to 5:30 p.m. / Closed Sun. The renter is responsible for the Trailer until it has been checked in, on the lot, by Cache Valley Trailer Rental Personnel. No trailers are to be dropped off during non-business hours, or left outside the lot, or on the curb. If Renter leaves the Trailer outside of the business lot or, renter will be charged a \$100 fee in addition to any other charges.

LEASE PERIOD: The rental period shall include all time consumed in transporting the Trailer. The rental period shall be measured from the date and time of day of delivery of the Trailer to Renter by Cache Valley Trailer Rental, to and including the date and time the Trailer is returned and checked in by Cache Valley Trailer Rental Personnel. Simply dropping the Trailer Rental off without Cache Valley Trailer Rental personnel present does not constitute a check in. Renter is still responsible for the rental and charges will continue to accrue until officially checked in.

RENTER IS RESPONSIBLE FOR ANY TIRE DAMAGE! Renter's initialed acknowledgement: _____

TIME OF RETURN: Renter's right of possession of the Trailer terminates on the expiration of the rental period when checked in by Cache Valley Trailer Rental Personnel. Any retention by Renter of Trailer after the time for its return constitutes a material breach of this rental contract, and subjects Renter to automatic loss of the Damage/Cleaning Deposit, and an additional late charge of \$100.00 per day, in addition to all other charges. Time is of the essence of this contract. Any extension of the time for return of the Trailer must be mutually agreed upon in writing, and in advance.

Renter's initialed acknowledgement: _____

I hereby acknowledge that I have rented and received the Trailer belonging to Cache Valley Trailer Rental LLC for my personal or business use. I have had the opportunity to inspect the Trailer and I find it suitable for my needs and in good condition. A full check out of the Trailer was given to me before I took it and I clearly understand everything discussed. Any questions I had about the Trailer have been satisfactorily answered. I understand its proper use and carrying capacities and will use it only for its designed purpose. I further acknowledge my duty to inspect the trailer prior to each use. If the Trailer becomes unsafe or inoperable as a result of any normal usage of it, I will discontinue my use of it and notify Cache Valley Trailer Rental who, upon return of the Trailer, will replace the Trailer with a similar Trailer in good working order, if available. Such discontinuance of use does not terminate my obligation to pay rental as set forth on this invoice.

DAMAGED EQUIPMENT: If the Trailer is returned in a damaged or excessively worn condition, Renter shall pay Cache Valley Trailer Rental the reasonable cost of us repair and/or replacement, to be determined solely by Cache Valley Trailer Rental immediately upon return of the trailer. Cache Valley Trailer Rental alone shall be responsible to affect repairs or replacement of the parts there of at Renter's expense. Reasonable wear and tear, for all purposes of this contract shall mean only normal deterioration and shall not include any deterioration caused by (i) lack of daily maintenance (ii) improper operation, (iii) overloading or exceeding the weight capacity of the Trailer (iv) collision, or (v) any other improper or negligent use of the Trailer by Renter or any other party, Renter shall pay the cost of the Trailer at Cache Valley Trailer Rental's regular retail replacement prices, which shall constitute additional rent owed under the terms of this contract. Accrued rental charges cannot and will not be applied against the cost of such repairs of such damage or loss or replacement, or both: _____

LIABILITY FOR INCORRECT DRIVER'S LICENSE/PERMITS: Renter shall be liable for any tickets or citations received due to Renter not holding the proper class driver's license and/or permits required to tow the Trailer being rented.

LIABILITY FOR ALL DAMAGES TO TRAILERS: Renter shall be liable for any loss, theft, damage, or destruction of Trailer from any cause whatsoever including, but not limited to any act or omission of Renter. This includes all the trailer and its accessories including lights, light cords, tires, spare tires, and ramps.

LIABILITY FOR DAMAGE TO CARGO: Renter assumes full responsibility and liability for any damages occurring to cargo which Renter transports with the Trailer, regardless of the cause of said damage.

LIABILITY FOR PERSONAL INJURY: The Trailer is used at Renter's own risk, and Cache Valley Trailer Rental assumes no responsibility to any person, including Renter, while the Trailer is not in the possession of Cache Valley Trailer Rental. The Rental shall inspect all chains, straps, binders, ropes, cords and bungees prior to their use, and at their sole discretion, determine if they are safe to use.

RENTER'S ASSUMPTION OR LIABILITY AND AGREEMENT TO INDEMNIFY CACHE VALLEY TRAILER RENTAL: RENTER AGREES, AT ITS SOLE COST AND EXPENSE, IT SHALL DEFEND AND INDEMNIFY CACHE VALLEY TRAILER RENTAL AGAINST AND HOLD THEM HARMLESS FROM ANY AND ALL CLAIMS, DEMANDS, ACTIONS AND CAUSES OF ACTION INCLUDING EXPENSES, COURT COSTS, AND ATTORNEYS' FEES ARISING OUT OF ANY INJURY (INCLUDING DEATH) OR DAMAGE TO ANY PROPERTY, WHICH IS ATTRIBUTABLE TO DIRECTLY OR INDIRECTLY OR RESULTS IN ANY WAY FROM THE USE OF THE TRAILER COVERED BY THIS RENTAL AGREEMENT REGARDLESS OF CAUSE OR ANY CONCURRENT OR CONTRIBUTING FAULT OF CACHE VALLEY TRAILER RENTAL. RENTER ASSUMES ANY AND ALL RISKS THAT SHALL INCLUDE, WITHOUT LIMITATION, THE RISK OF DEATH, BODILY INJURY OR PROPERTY DAMAGE RESULTING FROM THE USE OF THE TRAILER.

RELEASE OF & AGREEMENT NOT TO SUB CACHE VALLEY TRAILER RENTAL: Renter hereby releases Cache Valley Trailer Rental and all of its successors, assigns, subsidiaries, affiliates, officers, directors, employees, licenses, agents and any other party in privity of contract with Cache Valley Trailer Rental from, and agrees not to sue any or all of them on account of or in connection with any claims, causes of action, injuries, damages, costs or expenses arising out of its use of the Trailer of Renter's presence upon the facilities of Cache Valley Trailer Rental, including without limitation, those based on death, bodily injury or property damage.

LIABILITY INSURANCE COVERAGE: Renter's signature on this contract is Renter's representation that the Renter has current liability insurance coverage on Renter's towing vehicle(s), providing adequate liability and property damage for the Trailer when towed by said vehicle(s).

PROHIBITED USES: The following uses of Trailer are prohibited: (a) transporting dangerous or hazardous items or illegal materials, (b) transporting living persons, (c) towing of the Trailer by anyone under the influence of drugs or alcohol, (d) allowing the Trailer to be towed by anyone who is not a Renter or an Authorized Driver, (e) any use of this Trailer by anyone who obtained the trailer or extended the rental period by giving false, fraudulent, or misleading information, (f) use of the Trailer in furtherance of any illegal purpose or under any circumstance that would constitute violation of law, other than minor traffic citation, (g) use of the Trailer outside of the United States, (h) use of the Trailer where loaded beyond its capacity, as determined by the manufacturer of the Trailer, (i) continued use of the Trailer when it's reasonable to expect Renter to know that further operation would damage the Trailer, (j) using the Trailer in a manner that causes damage due to inadequately secured cargo, (k) damaging the Trailer by intentional, willful or reckless conduct and, (l) damaging the Trailer by placing signs, lettering or painting on the Trailer. (M) Acts of terrorism

RETAKEING OF TRAILER: If for any reason, Cache Valley Trailer Rental deems it necessary to retake the Trailer, Cache Valley Trailer Rental and its agents, employees or assigns may enter upon Renter's property and retake the Trailer without advance notice or legal process. Cache Valley Trailer Rental and its agents may take all action deemed reasonably necessary to retake the Trailer and Renter waives for himself/herself, or itself, his, her, or its agents and employees all claim for damages and loss, whether physical and pecuniary caused by the retaking of the Trailer by Cache Valley Trailer Rental. Renter agrees to pay all costs and expenses reasonably incurred by Cache Valley Trailer Rental in retaking the Trailer, including reasonable attorney's fees.

CHOICE OF LAW AND FORUM AND CONSENT TO PERSONAL JURISDICTION: Except to the extent prohibited by applicable law, this contract shall be interpreted; construed and governed by the laws of the State of Idaho, regardless of its place of execution or performance.

MISCELLANEOUS PROVISION: Renter agrees to all the terms of the contract as well as the provisions contained in the attached Rental Agreement and agree that all charges for rental, damage, cleaning or material will be paid by Renter and that all collection fees, court cost or any other expense involved in the collection of these charges will be borne by the Renter. This contract constitutes the entire agreement between the parties and any other representations, oral or otherwise, are void unless explicitly set forth in this contract.
